Notice is hereby given that sealed bids will be received by the City of Bonney Lake, 9002 Main Street East, Suite 125, P.O. Box 7380, Bonney Lake, WA. 98391, until **March 27, 2019 at 11:00 AM** for the **West Tapps / Allan Yorke Park Sidewalk Project**.

Work to be performed includes improvements to the following:

- 880LF of curb, gutter, and 5-foot wide sidewalk along west side of West Tapps Hwy. East
- Provide storm water collection and quality treatment system as required by the 2015 PC Stormwater Manual
- Convert existing overhead utilities to a joint underground trench
- Illumination at intersections (provided by Intolight)

Bid proposals will be received only at the City Clerk's Office at the City of Bonney Lake, 9002 Main Street East, Suite 300, P.O. Box 7380, Bonney Lake, WA 98391 by **March 27, 2019 at 11:00 AM**, at which time they will be opened, read, and tabulated publicly. Clearly identify project name on all submitted bid packages. Proposals received after the time fixed for opening will not be considered.

The Contractor will be required to comply with all local, State, and Federal laws and regulations pertaining to equal employment opportunities.

Each bid proposal shall be accompanied by a bid proposal deposit in cash, certified check, cashier's check, postal money order, or surety bond in an amount equal to at least five (5) percent of the amount of such bid proposal. Checks shall be made payable to the City of Bonney Lake. Should the successful Bidder fail to enter into such contract and furnish satisfactory performance and payment bond within the time stated in the Specifications, the bid proposal deposit shall be forfeited to the City of Bonney Lake.

The City of Bonney Lake Reserves the right to reject any or all bids and to waive irregularities in the bid or in the bidding.

No Bidder may withdraw his proposal after the hours set for the opening thereof, or before award of contract, unless said award is delayed for a period exceeding sixty (60) calendar days.
