Notice is hereby given that sealed bids will be received by the City of Bonney Lake, 9002 Main Street E, Suite 125, Bonney Lake, Washington 98391, until **10:00 a.m. on Wednesday, January 16, 2019**, for the **95th Street Bypass Trail**.

Work to be performed includes:

The project includes construction of approximately 370 linear feet of pile supported boardwalk, approximately 550 linear feet of at-grade porous HMA joint use trail along the embankment of SR410, procurement and installation of one prefabricated steel bridge, 185 linear feet of sidewalk, and the installment of 550 linear feet of soldier pile wall in the embankment of SR410 and 55 linear feet of block wall.

Bid proposals will be received only by the City Clerk at the City of Bonney Lake, 9002 Main Street E, Suite 125, Bonney Lake, Washington 98391 by 10:00 a.m. on Wednesday, January 16th, 2019, at which time they will be opened and read publicly. Clearly identify project name on all submitted bid packages. Proposals received after the time fixed for opening will not be considered.

Each bid proposal shall be accompanied by a bid proposal deposit in cash, certified check, cashier's check, postal money order, or surety bond in an amount equal to at least 5 percent of the amount of such bid proposal. Checks shall be made payable to the City of Bonney Lake. Should the successful bidder fail to enter into such contract and furnish satisfactory performance and payment bond within the time stated in the specifications, the bid proposal deposit shall be forfeited to the City of Bonney Lake.

The City of Bonney Lake reserves the right to reject any or all bids and to waive irregularities in the bid or in the bidding.

No bidder may withdraw his proposal after the hours set for the opening thereof, or before award of contract, unless said award is delayed for a period exceeding sixty (60) calendar days.
