

ORDINANCE NO. 1549

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BONNEY LAKE, PIERCE COUNTY, WASHINGTON, AMENDING CHAPTER 9.01.010 OF THE BONNEY LAKE MUNICIPAL CODE AND ORDINANCE NO. 1444 RELATING TO THE ADOPTION OF STATUTORY PROVISIONS TO ADOPT NEWLY CODIFIED RCW 18.108.030 AND 18.108.035 RELATED TO THE UNLICENSED PRACTICE OF MASSAGE.

WHEREAS, the Bonney Lake City Council wishes to promote safety and equity in the enforcement of criminal laws within the City of Bonney Lake; and

WHEREAS, the Bonney Lake City Council wishes to continue to adopt and incorporate certain criminal laws contained in the Revised Code of Washington.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF BONNEY LAKE, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Section 9.01.010 of the Bonney Lake Municipal Code is hereby amended to include the adoption of RCW 18.108.035 Unlicensed Massage Practice to read as follows:

9.01.010 Statutory provisions – Adopted by reference – Scope.

The following laws contained within the Revised Code of Washington (RCW) are hereby adopted by reference as currently enacted and as hereafter amended from time to time, and shall be given the same force and effect as if set forth herein in full; provided, that any provision in the RCW dealing solely and exclusively with the investigation, prosecution, or sentencing of a felony crime is not adopted herein.

Massage Practitioners

18.108.030 Licensure or certification required.

18.108.035 Unlicensed practice—Penalties.

Section 2. The city clerk shall sign and file with the adopting ordinance a copy of the statutes and regulations referenced herein and shall also file and maintain the city clerk's office one copy of each of the adopted laws in the form in which they were adopted for use and examination by the public.


Section 3. This Ordinance shall take effect and be in force thirty (30) days from and after its passage, approval and publication, as required by law.

Full Title/Motion: An Ordinance of the City Council of the City of Bonney Lake, Pierce County, Washington, Adopting RCW 18.108.030 and 18.108.035, Relating to Unlicensed Practice of Massage.

Administrative Recommendation:

Background Summary: The Washington State Department of Health opines that over the last few years, there has been a disturbing trend of massage parlors or foot massage parlors serving as fronts for prostitution and sex trafficking businesses. They also bring public confusion on the legitimate practice of massage therapy as a health profession. While the Department of Health can currently impose a civil fine against individuals for the unlicensed practice of massage and reflexology, criminal sanctions will have a greater impact on stopping illegal and disreputable practices.
